At the outset, the Convener welcomed the members and informed that during the Academic Session 2022-23, no complaint about Ragging of students has been received so far.

The Convener also apprised the members about receipt of the letter No. DO/1-15/2009(ARC) pt. III dated 16.09.2022 from the UGC, which is suggestive of placing an appropriate mechanism to make the campus free from ragging activities. Members expressed their satisfaction about the zero ragging incidences on the campus, which is a specialty of our institution and emphasized that the sprit should be maintained in future also.

The Chairman also informed that UGC has revised procedure for students to file online Anti Ragging Affidavit which has been conveyed vide UGC Letter No. DO F-3-2/2021(ARC) dated 27.10.2021 in pursuance of the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in civil Appeal No. 887/2009. To reduce compliance burden of its stake holders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

- 1. The Revised Procedure is as under:-
 - Step -I It is the same like before.
 - Step-II The student will receive email with a Registration number and a web link will be provided. He/she will forward the same to the in-charge faculty of the Department. He/she is not required to print & sign the same.
 - Step-III- The in-charge faculty of the Department will update on the link of any forwarded email which the student has submitted as Anti-Ragging Affidavit/undertaking in the department stating that the student has participated in confidential survey of the UGC.

 The list will be updated every 24 hours.
- The email address and contact number of the faculty concerned shall be uploaded on the website and every candidate of the Department would be informed about the revised procedure to file online Anti Ragging Affidavit.
- As per advice of UGC, the University has created E-admission booklet or brochure, E- leaflets giving details.
- 4. In the Admission form, the following column may be inserted.

After uploading the forms on the website, concerned teachers be advised to deposit hardcopies of the forms in the office of Sh. V. K. Sharma, Academic Officer by 30.10.2022.

- 7. Anti-ragging posters be downloaded from the UGC website and displaced at all the prominent places including the Boys hostel, Girls hostel, AKKM, All Departments, canteen, Library, common facilities etc. Mr. V.K. Sharma shall look after this activity.
- 8. Anti-ragging warning has already been published in the University Prospectus at page no. 13-15. Constitution of the Anti-Ragging Cell and Anti-ragging squad along with complete address and contact details has been completed and has been displayed on various Notice Boards as well as uploaded on the university website in compliance of the UGC regulation including its 2nd amendment.
- 9. Necessary information regarding definition of Ragging shall be made available and explained to the students by the above said teachers during the class. Teachers may arrange a meeting of students with the committee (Anti Ragging Cell and Anti Ragging Squad).
- 10. CC TV cameras have already been installed at the vital points.
- 11. Regular instructions and counseling with the students be made by the committee and a sincere effort be made to identify of trouble triggers, if any.
- 12. Events like Anti Ragging workshop/Seminar and other creative avenues to spread the idea be arranged.
- 13.. Alarm in the hostel has already been installed. Similarly CC TV cameras have been installed there for ensuring safety and security.
- 14. Students may be informed about Anti Ragging helpline during interaction with the students as well as during the seminar/webinar as and when organized by the committee.
- 15. Anti-Raging squad may make surprise inspections at the hostels, canteen etc. from time to time.
- 16. Students members should be vigilant and remain in touch with students in general at regular intervals and they may be informed that ragging is a criminal offence and they must adopt the guideline issued by the UGC in curbing the menace of ragging and violation of which would be viewed seriously and cause serious complications. Students should not indulge themselves in any activity of Ragging. All stake holders would try their best that newly admitted students study in a fear- free atmosphere.
