## NOTE:

- 1. The above vacancies are provisional and subject to variation at any time. The Institute reserves the right to vary the vacancies including reserved vacancies.
- 2. Reservation is applied as per Rules.
- 3. Age, experience and all other prescribed qualifications will be counted as on last date of submission of application.
- 4. For Doctor (Naturopathy) the incumbent should possess a Bachelor Degree (BNYS) from a recognized institution. Experience of working in a hospital/centre shall be preferred. A minimum 3-years' experience is must (except internship).
- 5. For Therapist (Naturopathy), the incumbent should be a diploma holder from a recognized institution. Experience of professional working shall be preferred.
- 6. For Dietician, the incumbent should possess a Bachelor Degree (Bachelor of Science in Nutrition and Dietetics) from a recognized institution. Experience of working in a hospital/centre shall be preferred.
- 7. For Housekeeping Supervisor, the incumbent should possess a Bachelor Degree from a recognized institution. Experience of working in a hospital / spa shall be preferred.
- 8. For Admin Assistant, the incumbent should possess a Bachelor Degree from a recognized institution and have experience of working in stores/purchase in the hospital/hospital industry.
- 9. For Receptionist, the incumbent should possess a Bachelor Degree with minimum 2-years' experience in the same field.
- 10. Relaxation of Experience for SCs/STs/OBC in Direct Recruitment, if any, may be considered by the Competent Authority as per norms.
- 11. Eligibility of a candidate shall be subject to the UGC Regulations.
- 12. Candidates are required to enclose copies of the self-attested supporting documents with the application.
- 13. Knowledge of English is must.
- 14. The prescribed qualification is minimum and mere possessing the same doesn't entitle any candidate to be called for interview or for selection.
- 15. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by the Competent Authority at time of Interview.
